OPEN MEETING OF STAFF, GRADUATES AND UNDERGRADUATES

The Open Meeting of Philosophy Staff and Students was held on Thursday 21 October 2010 at 1.10 p.m. in the Philosophy Board Room, Faculty of Philosophy, Sidgwick Site.

Professor Crane opened the meeting by asking everyone to introduce themselves.

- 1 Minutes of the Open Meeting of 22 October 2009 were approved.
- 2 Brief report by the Chair of the Faculty, Professor Tim Crane:
Professor Crane briefly reported on the business of the past academic year. He mentioned staff changes for 2010–11, and he also informed the meeting that Professor Blackburn and Dr Smith will retire at the end of this academic year. He talked about some changes made to the Tripos, such as the renaming of some papers and borrowing of others.

Professor Crane thanked students involved in the General Board Learning and Teaching Review. The report together with the Faculty's response will be made available for consultation in the Philosophy Library.

Professor Crane also reminded students that the unreserved minutes of the Faculty Board meetings are available for consultation in the Faculty Office, as are the minutes of the Staff-Student Committee meetings.
