 - 2 Starring of items was invited.
 - 3 Apologies for absence were received from Dr Nikhil Krishnan.
 - 4 The minutes of the meeting held on 5 May 2020 were approved. These minutes were previously circulated to all students via email for information.
 - 5 <u>Matters arising from the minutes not raised elsewhere on the agenda</u> Item 11: <u>Discussion Group readings and an undergraduate led reading group</u>

The proposed changes for discussion group readings were initially considered at the ethics, politics and aesthetics caucus meeting on 11 May 2020, but further discussion was needed during 2020-21 before making possible changes for a future year. Jack Walker and Amanda Astley have set up an undergraduate led reading group for IA students starting November 2020.

6 <u>Student-Staff Committee</u>

a) A short outline of the way the Student-Staff Committee functions was circulated **for information**, and **any questions**.

b) Year Delegates on the Student-Staff Committee Volunteers were sought from all Parts of the Tripos and the MPhil and PhD programmes to be a representative for their year group at Staff-Student Committee, a different function from the elected Faculty Board Representatives. There were no volunteers. In practice not all students would wish to attend all meetings but it was hoped/expected that at <u>least two</u> delegates from each year would regularly attend.

7 Election of Student Representatives

It was noted that the elections for student representatives on the Philosophy Faculty Board would be held on **Tuesday 17 November 2020** with the closing of nominations a week earlier on **10 November 2020**. Results would be announced centrally on **Friday 20 November**.

Council representatives

It was noted that all students on the electoral roll would also have the chance to be elected to serve on Councils of the Schools. These elections would take place across 16-19 November 2020.

8 Teaching Arrangements 2020-21

It was noted that the Faculty was reviewing the teaching and learning arrangements that had been introduced in light of the pandemic. Feedback had already been received from student reps, and proposed revisions to teaching arrangements would be discussed. John Filling reported on the latest changes notably that pre-recorded teaching material would be made available *throughout the academic year*. Recordings of live sessions are at the session leader's discretion. Students with SSDs or with extenuating circumstances would be always be provided with content as appropriate. It was also noted that students may have other extenuating circumstances e.g. loss of internet for prolonged periods of time. Further student feedback was invited on these changes or any other online teaching arrangements.

Student feedback welcomed the recorded material extension and cautioned against possible student procrastination due to the longer availability. JF explained that the extension decision would be reviewed in time but if any future change meant a reduction to the extension, availability would not be for less than a term.

9 Lecture handouts

It was explained that some handouts would be made available to students outside of lectures. These could be found on Moodle for the relevant paper or the lecturer's own websites. Access to these Moodle pages is be restricted to students taking Philosophy papers and is administered by Faculty Office staff.

10 Lecture questionnaires

Students were encouraged to complete the questionnaires, which it was explained would be online this year. Lecturers would be asked to remind students, where possible, in their last lecture to fill in a feedback questionnaire for the lecture course. Students would also be encouraged to complete questionnaires for Discussion Groups and Logic Classes.

The deadline for MT20 feedback questionnaires would be midnight on Monday 7th December 2020.

14 Extended Essays in Part IB/Extended Essays and Dissertations in Part II

Students were reminded that the deadline for submitting extended essay and dissertation titles was **12:00 noon on Friday 20 November 2020**.

All titles have to be approved by the Chair of Examiners before the end of Michaelmas Term, on 4 December 2020.

Students were also asked to note that any student who does not submit their Extended Essay on time, would have no option but to sit the corresponding exam paper. Any student who did not submit their dissertation on time would effectively fail the paper, as the deadline for submitting dissertations was after the final deadline for amending exam entries.

At the Faculty Board meeting on 20 May 2020, the Faculty Board agreed on specific action points which we are in the process of implementing. One of these action points is reviewing our documentation and invitations to bought-in lecturers to make sure that everyone involved in teaching has University training in equality and diversity matters and that they know about the University's sexual harrassment policy.
